Such activities may include, but are not limited to, camps, athletic games, excursions, mission trips and meetings. I acknowledge that my participation in any Mission Hills Church activity presents risks that I may suffer property damage, bodily injury, or death. Therefore, in consideration of my participation in the Mission Hills Church activities, I agree to the following:

**PLEASE INITIAL EACH STATEMENT:**

INITIAL:  Mission Hills Church is not responsible for my personal belongings.

INITIAL:  I consent to have photographs taken of myself during the Mission Hills trips and activities. The pictures may be used on the Mission Hills Web Page, in future brochures, or in slide shows during and/or after the event without compensation or notification.

INITIAL:  I am required to wear seat belts while riding in church provided transportation other than rental buses. I am responsible to keep my seat belt on while en route to activities.

INITIAL:  I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns: a) I waive, release, and discharge from any and all claims or liabilities for death or personal injury damages of any kind, which arise out of or relate to my participation in Mission Hills Church activities, the following person or entities: Mission Hills Church, its Senior Pastor, Associate Pastors, Program Staff, Elders, employees, volunteers, representatives, subcontractors and agents of any of the above; b) I agree not to sue any of the persons or entities mentioned above for any of the claims or liabilities that I have waived, released or discharged herein; and c) I indemnify and hold harmless the person or entities mentioned above from any claims made or liabilities assessed against them as a result of my actions. I agree to indemnify and hold harmless the persons or entities mentioned above for any claims or liabilities assessed against them as a result of any insufficiency of my legal capacity or authority to act for and on behalf of myself in the execution of the Waiver and Release. **I hereby assume the risks of my Participation in all Mission Hills Church Activities.**

**INSTRUCTIONS TO CREATE A DIGITAL SIGNATURE:**

**Fill out document** (red fields are required before submission is possible) (Please make sure all information is correct before signing the document as you will no longer be able to make changes once the signature is in place).

**Check the box for submitting electronically**

**Click on the Signature field** (the one with the red flag in the upper left corner)

A dialog box will open asking you what you want to do next. **Select "A new digital ID I want to create now"**

**Click "Next"**

**Select "New PKCS#12 digital ID File" - Click "Next"**

**Confirm that all information is correct and click "Next"**

**Browse to a location on your computer** where you want the Digital ID file to be stored for future use (**Suggestion:** write down that location so you can find it again later if you need to). Then create and confirm a password of your choice (you'll have to remember that password as well)

**Click "Finish"**

**Enter your password and then click "Sign"** It will ask you to save the document. You can save it to your desktop or a location of your choice) **Click "Save"**

The Document will now be signed and encrypted. You will no longer be able to make changes.

**NOTE:** The Children's Ministry Staff will not be able to make changes to this document either. They will save a copy of this file in a secure location on the MHC Server and will then permanently delete your e-mail. This will ensure your privacy.
